In the official notification by UPSC for UPSC Civil Services Examination, you will see that before the UPSC Mains Syllabus, following important points are mentioned. You must go through them.

- It does not test merely memory or information but the intellectual depth of the candidate.
- A well educated person should be able to answer without any specialised study.
- It tests general awareness and basic understanding in a variety of subjects.
- Candidate should be capable of analysing, forming views on conflicting socioeconomic goals.
- Answers should be relevant, meaningful and succinct.
- Optional Paper level is of Bachelors Degree (Honours)
- Medical Science, Engineering and Law optionals are of Bachelors level.

Qualifying Paper on Indian Language and English

The aim of the paper is to test the candidates' ability to read and understand serious discursive prose, and to express his ideas clearly and correctly, in English and Indian language concerned.

Important Points to Note

- The papers on Indian Languages and English will be of Matriculation or equivalent standard and will be of qualifying nature only. The **marks obtained in these** papers will not be counted for ranking.
- The candidates will have to answer the English and Indian Languages papers in English and the respective Indian language (except where translation is involved).

Paper I: Essay

Candidates may be required to write essays on multiple topics. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression.

Paper II: General Studies I Syllabus

Indian Heritage and Culture, History and Geography of the World and Society.

- Indian culture will cover the salient aspects of Art Forms, literature and Architecture from ancient to modern times.
- Modern Indian history from about the middle of the eighteenth century until the present- significant events, personalities, issues.
- The Freedom Struggle its various stages and important contributors/contributions from different parts of the country.

Human Values lessons from the lives and teachings of great leaders, reformers and administrators; role of family society and educational institutions in inculcating values.
- Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- Aptitude and foundational values for Civil Service, integrity, impartiality and nonpartisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- Emotional intelligence-concepts, and their utilities and application in administration and governance.
- Contributions of moral thinkers and philosophers from India and world.
- Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values in governance; ethical issues in international relations and funding; corporate governance.
- Probity in Governance: Concept of public service; Philosophical basis of governance and probity; Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery, Utilization of public funds, challenges of corruption.
